By General Manager directive, Quality and Chain of Custody Manager has established and implemented an Integrated System of Quality Management and Chain of Custody, based on the requirements of the UNE-EN-ISO 9001 (2015): "Quality management system, requirements", UNE-EN-ISO 14001 (2015): "Environment Management system, requirements" and PEFC ST 2012:2020. Chain of Custody for Forest products and PEFC controlled sources. Requirements for the MANUFACTURE OF PALLETS.

The integrated system has the purpose to promote and contribute to sustainable forest management, through the control of sources in its raw material and, on the other hand, the satisfaction of customers (internal, external and Interested parties), and at the end, the protection of environment, including prevention of contamination, sustainable use of resources, mitigation and adaptation of climate change, and protection of ecosystems thanks to the fulfillment of the established requirements, and in the terms set. For this, the system has as objectives:

- Quality Assurance of the products supplied, and services provided.
- Fulfillment of the requirements offered to our clients, consolidating the trust in our organization.
- Compliance with all the legislation and other requirements applicable to our activity and to the environment.
- Effective management and control of the production process and service delivery.
- Continuous improvement of processes, procedures, services and environmental performance.
